Snowflake Town Ordinance 7-1-4: Riding Vehicles on Grounds:

No person shall at any time drive or ride on any automobile, truck, motorcycle, motor scooter or other motor vehicle upon the grounds of any Town park, playground, ball field, golf course, except in public streets running through such premises or within designated parking areas located upon such premises, without the written permission of the Town Manager or such person as the Town Council may designate.

(1986 Code 11-1-2)

Fee Classification

Arts & Crafts

Hand-Crafted Items: Vendors who personally make all of the crafts they sell. If you sell items that the Snowflake/Taylor Chamber defines as commercial, you will be classified as a commercial vendor. Cost of a 10X10-foot vending space is \$75.00

Commercial Items: Vendors selling items that are not hand-crafted by themselves, and/or sold through a commercial outlet, fit into this category. Cost for a 10X10 foot vending space is \$125.00

Food Vendors

There are two (2) categories of Food Vendors: Homemade Products: \$75.00 or Commercial: \$125.00

Entertainment

Interactive games, animal rides, rock-climbing walls, bouncers, etc. Proof of insurance is required from entertainment vendors. Space will be negotiated as needed. Fee: \$150.00

Licensing, Fees & Permits

All vendors must be licensed through the State of Arizona and must file a Transaction Privilege Tax Application (short form) with the Arizona Department of Revenue. The state assesses a \$12.00 fee plus a \$2.00 city fee at the time the form is filed. The form may be downloaded off the Arizona Department of Revenue website at www.revenue.state.az.us/Forms/Transaction.asp The form is called "Form for Special Event Licensing"

Licensing, Fees & Permits Cont.

Food vendors must have a valid license and must be able to pass an on-site inspection. For more information, contact the Navajo County Health Department at 928-524-4750 Ext. 13

Vendor Requirements

- Vendors are required to obtain licenses and insurance at their own expense. The promoters of this event comply with all state and town laws.
- Vendors are responsible for their own tables, chairs, canopies and the delivery and handling of their own displays, and all their other materials.
- Vendors need to provide their own power sources unless otherwise noted and confirmed in advance.
- Vendors are responsible for their own lodging and all other personal expenses.
- All vendors are required to stay until close of show. 5pm on Friday and 4pm on Saturday.
- Vendors must leave their space clean and undamaged.
- All food vendors must bring two (2) large trash cans and their own plastic liners.
- For vendor convenience, security will be provided Friday night. Vendors may choose to leave their tables and tarps assembled overnight. However, all vendors must stay on site until security arrives on Friday afternoon, and must vacate the fair area at that time. After security has closed the area, no one will be allowed back on site until 7am Saturday morning.
